 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this Privacy Policy;

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
- d. "including" is understood to mean "including without limitation";
- e. reference to any statutory provision includes any modification or amendment of it;
- f. the headings and sub-headings do not form part of this Privacy Policy.

Scope of this Privacy Policy

- 3. This Privacy Policy applies only to the actions of Nick Stolerman & Associates Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Nick Stolerman & Associates Limited is the "data controller". This means that Nick Stolerman & Associates Limited determines the purposes for which, and the manner in which, your Data is processed.

Data Collected

- 5. We may collect the following Data, which includes personal Data, from you:
 - a. name;

How We Collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - b. data is collected automatically.

Data That is Given to Us by You

- 7. Nick Stolerman & Associates Limited will collect your Data in a number of ways, for example:

in each case, in accordance with this Privacy Policy.

Data That is Collected Automatically

Keeping Data Secure

- 14. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

Data Retention

Your Rights

- 19. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - **b. Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - **c. Right to erase** the right to request that we delete or remove your Data from our systems.
 - **d. Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
 - e. Right to data portability the right to request that we move, copy or transfer your Data.
 - **f. Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
